Scheduled Election

Fair Work (Registered Organisations) Act 2009

Nominations are called for:

- Branch Vice-President (1)
- Executive Members (4)
- Branch Councillors (14)

Nominations, which must be in writing and comply with the registered rules of the Federation, may be made at any time from Monday 5 August 2019.

Nomination forms are available on request.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Federation's rules prior to lodging nominations.

Note: Rule 84.1 A candidate for election to the office of Branch President, Branch Vice President, Branch Executive member or Branch Councillor shall have been a financial member of the Federation for a period of one year immediately preceding the date of nomination for office and shall be a member of the branch in which they are nominating for office at the date of nomination for office.

Note: Rule 84.4 Candidates must be nominated by three other financial members of the Branch.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 12 noon Australian Eastern Standard Time (AEST) **on** Monday 26 August 2019.

Withdrawing Nominations

Nominations cannot be withdrawn after 12 noon AEST Monday 26 August 2019.

Candidate Statements

Note: Rule 85.5 Candidates may submit a statement not exceeding two hundred words, together with a photograph of themselves (if desired) to be included with the ballot material.

Only statements which comply with the Federation's Rules and are received by the Returning Officer by 12 noon AEST Monday 2 September 2019 can be accepted.

Voting Period

The ballot, if required, will open on Monday 23 September 2019 and close at 5pm AEDT on Monday 14 October 2019.

Scrutineers

Note: Rule 87.1 A candidate in any Branch election may, if he or she so desires, appoint a scrutineer who is a financial member of the Federation to represent him or her at the ballot. The person appointing a scrutineer shall before the commencement of the ballot, notify the Returning officer in writing of the name of such scrutineer.

The appointment of scrutineers closes 9:30am AEDT on Tuesday 15 October 2019.

A scrutineer appointment form is available from the Returning Officer.
