## Public sector mental health enterprise agreement: campaign update #10

### 1. **Next statewide members meeting re-scheduled to Monday 9 May at ANMF - 2.30pm**

The next ANMF public mental health EBA members meeting has been re-scheduled from Thursday 5 May and will now be held on **Monday May 9 at 2.30pm**.

The meeting has been changed as ANMF expects we will be in a better position to inform mental health members about the progress of all of our public sector negotiations, including the claims for improved wages. The mental health members meeting will be held at the Carson Conference Centre at ANMF House.

Your negotiation team requests that you commit to attending this important meeting as we will be reporting on the progress of negotiations on your claims and discussing with ANMF members how you want to respond, including determining what and when to commence protected industrial action. If a group of 10 or more are attending from your workplace, and you would like transport to be arranged, please inform us via the registration portal.

### 2. **Australian Electoral Commission (AEC) protected industrial action (PIA) ballot outcomes**

The Fair Work Commission has not yet published the results of the protected action ballots. Once these results are declared, ANMF will provide a further update.

### 3. **Forensicare update**

The Forensicare protected action ballot opened on 18 April and will close at 5pm on 10 May. The ballot will be counted by the AEC at 10am on 11 May. ANMF encourages members to **vote 'yes' for your right to take protected industrial action, in the event that action is required**. If you have not received your ballot paper by Friday 22 April, you need to contact the AEC and make an application for replacement ballot material. Join the campaign, attend meetings and achieve the improvements we deserve. Enterprise bargaining time is the most critical opportunity to improve our wages and conditions. Our strength is our membership. Most Victorian nurses and midwives are already ANMF members – if you haven't joined yet or you know someone who hasn't, please encourage them to join.
