



Background

ANMF (Vic Branch) has established a grant specifically aimed at providing financial assistance to refugees who have a nursing qualification and are seeking to obtain registration with the Nursing and Midwifery Board of Australia or who are undertaking a pre-registration nursing program here in Victoria.

An amount of \$4000 will be available annually and funds may be allocated to applicants who meet the following criteria. Money allocated may be used to purchase books, stationary, uniforms, and travel costs to clinical placements will be on a reimbursement basis. Reimbursement for other costs may be considered.

All applicants should have received or be in the process of obtaining Australian refugee status.

All successful applicants will be excluded from further financial assistance through this grant process for total of 12 months.

In certain circumstances money may be provided to financially assist non refugee overseas nurses undertake the English language course requirements. In these circumstances it will be to assist nurses who have had to undertake repeated English courses (IELTS or OET).

These applicants must also provide up to 300 words on why the applicant wishes to receive financial assistance to obtain their English course qualification as well as evidence of acceptance into the English course.

Application details

Selection Criteria

Applicants must:

- have received or be in the process of obtaining Australian refugee status
- provide up to 300 words on why the applicant wishes to receive financial assistance to obtain a nursing qualification in Victoria.
- Those with a nursing qualification must:
 - be required to undertake an undergraduate or supervised practice program in order to gain registration with the Nursing and Midwifery Board of Australia;
 - provide confirmation of acceptance into such program with details of associated costs.
- Those wishing to undertake an undergraduate nursing program must:
 - provide a copy of their confirmation of enrolment in an accredited nursing undergraduate program leading to registration as either a Registered Nurse/Midwife or Enrolled Nurse.




